WE HAVE SEVERAL PEOPLE WHO FIELD PHONE CALLS FROM OUR VIEWER SERVICES DEPARTMENT TO ANSWER QUESTIONS, BOTH INFORMATIONAL AND TECHNICAL. THIS IS AN ONGOING EFFORT BY THE EMPLOYEES OF THIS STATION.

THE MEMBERSHIP DEPARTMENT ALSO SENDS OUT REGULAR EMAILS REGARDING THE TRANSITION TO ITS DATABASE OF VIEWERS AND VOLUNTEERS (APPROXIMATELY 3000 TOTAL).

WE HAVE WORKED VERY HARD TO SATURATE OUR AIR WITH DTV AWARENESS MESSAGES. IN JULY 2008, WE AIRED A TOTAL OF 3 HOURS, 1 MINUTE OF DTV SPOTS, WITH 1 HOUR 56 MINUTES AND 10 SECONDS OF THAT BEING IN PRIME TIME. IN AUGUST, A TOTAL OF 2 HOURS, 23 MINUTES, 20 SECONDS WITH PRIME TIME ACCOUNTING FOR 1 HOUR, 30 MINUTES AND 20 SECONDS. IN SEPTEMBER, THE TOTALS WERE 2 HOURS, 39 MINUTES, 50 SECONDS OVERALL, WITH 1 HOUR, 33 MINUTES OF THAT TIME IN PRIME TIME.
